- Pay bills as presented within Board approved appropriation limits
- Modify appropriations within funds, and to report modifications to the Board of Education for approval
- Borrow funds within the limitation of the law
- Prepare "blanket certificates" and "super certificates" in an amount not to exceed \$100,000 for specific recurring reasonably predictable operating expenses
- Secure tax advances from the County Auditor when funds are available
- Sign warrants using own or facsimile signature
- Make application for and accept State, Federal, and other funds
- Secure and keep current a position bond for the Treasurer in the amount of \$100,000.00.

- Invest all school funds in accordance with Ohio Revised Code.
- Allocate interest earnings to the following funds:
  - (001) General Fund
  - (002) Bond Retirement
  - (006) Cafeteria
  - (007) Special Trust (Catherine I Seigfried  
Robert & MaryAnn Honeychuck Scholarship)
  - (008) Endowment Scholarship
- Accept donations on behalf of the Board of Education up to \$500.00.

Member Porter moved, seconded by Member Stewart that the Field Local Board of Education authorize the Superintendent to: **22-0013**

- Act as purchasing agent for Field Local School District
- Approve all special trips on school buses, including educational field trips for band and athletic activities, based on guidelines as defined in Board Policy
- Approve the attendance and reimbursement of expenses by certified and non-certified staff members at professional and/or in-service training meetings, based on guidelines as defined in Board Policy
- Employ qualified regular employees and eligible certificated substitute personnel on a temporary, casual or as-needed basis in accordance with (O.R.C. 3319.10.)
- Accept resignations on behalf of the Board.
- Make offers of employment directly to candidates for either teaching or nonteaching positions when the Board is not in session. The employment shall be deemed effective as of the date and time of the employee's acceptance of the Superintendent's offer.

Member Stewart moved, seconded by Member Miller that the Field Local Board of Education designate the Record Courier and Akron Beacon Journal as the official newspapers for the Field Local Board of Education. **22-0014**

Mr. Carpenter noted some of the significant differences on the two calendars presented. The Board will make the final approval in February.


Public notices for this hearing were properly advertised. Notices were posted on our district website and websites of each school.
